# Legislative Coordinating Commission Office on the Economic Status of Women Minnesota Legislative Session Summary 2007

This report highlights and summarizes selected legislative changes related to the economic status of women in Minnesota. In addition to the funding and policy bills highlighted here, three policy bills followed by the OESW did not pass this session, and will likely be addressed in upcoming debates.

Policy that extended heath care benefits to domestic partners of state employees was in the original State Government Omnibus bill vetoed by the Governor. The section was not included in the bill that he later signed.

A second provision in the original State Government Omnibus bill required companies of a certain profile with large state contracts to participate in a pay equity reporting process similar to the one currently followed by the State of Minnesota and local governments. This provision was also not included in the omnibus bill signed by the governor.

A bill to regulate international marriage brokers who do business in Minnesota was not heard in committee. This issue is an extension of human trafficking work the OESW has been involved with in the past few years.

# **Adult Basic Education (ABE)**

Provides education opportunities for adults who lack basic academic skills and whose low educational levels are barriers to employment and productive participation in their families and in society. Adults are eligible to participate when they are at least 16 years old, are not enrolled in school, and function below the high school completion level in basic skills.

# All Day Kindergarten Grants (First Grade Preparedness)

Provides funding to ensure children in the state's highest poverty schools have the opportunity before first grade to develop the skills and abilities necessary to learn to read and succeed in school. School sites have used these funds to fund full-day kindergarten programs for five year olds.

# Early Childhood Family Education (ECFE)

Provides early childhood education, parent-child learning opportunities, and parent education that enhances the ability of parents to provide for their children's optimal learning and development. All Minnesota families with children ages birth to kindergarten are eligible for ECFE.

# **Interest on Monetary Judgments**

Previous law placed an additional 2% above the current interest rate placed on other monetary judgments in Minnesota. A new law intended to encourage obligors to stay current with child support payments eliminates the increase.

# Children Residing in a Foreign Country

A new law allows a deviation from the order amount of child support if a child has lived in a country with a substantially higher or lower cost of living for more than one year.

**Child Care Assistance Program (CCAP)** 

CCAP includes the Minnesota Family Investment Program (MFIP), Transition Year (TY) and Basic Sliding Fee (BSF) child care assistance programs which subsidize the child care expenses of low-income families based on a sliding fee of family co-payments for authorized work, education, and job search activities.

# **Children and Community Services Grants**

Children and community services grants provide funding to counties to purchase or provide social services for children and families. The Children and Community Services Act, enacted by the 2003 Minnesota legislature, consolidated 15 individual state and federal grants into a single program including: Crisis Nursery, Homeless Children, Children of Substance Abusing Mothers, Children whose Mothers are Incarcerated, Family Preservation, Mental Health Adolescent Services, and Juvenile Mental Health Screening.

# Minnesota Family Investment Program / Diversionary Work Program Grants

The Minnesota Family Investment Program (MFIP) is the state's welfare reform program for low-income families with children. MFIP includes both cash and food assistance. When most families first apply for cash assistance, they will participate in the Diversionary Work Program (DWP), a four-month program that helps parents go immediately to work rather than receive longer term assistance. To be eligible to participate in either MFIP or DWP a family must include a minor child or pregnant woman and meet citizenship, income, and asset requirements.

# **Support Services Grants**

Provides employment, education, training, and other support services to help low-income families and people avoid or end public assistance dependency. Also funds a portion of county administration for the MFIP and DWP.

# **HEALTH CARE GRANTS**

Health care grants purchase preventive and primary health care services, such as physician services, medications, and dental care for low-income families with children, elderly and people with disabilities.

Minnesotans can receive health care through the state's three publicly funded health care grant programs — Medical Assistance (MA - Minnesota's Medicaid program), MinnesotaCare and General Assistance Medical Care (GAMC). Applicants for the programs must be Minnesota residents and meet program specific eligibility requirements including income and asset limits.

### **CONTINUING CARE GRANTS**

# **Aging and Adult Services Grants**

Aging and adult services grants provide: nutritional services; transportation, chore services and other social support services; health screening and promotion services; older adult volunteer community services projects; care and one-on-one attention for special needs children (through the Foster Grandparents program); assistance with daily activities for frail older adults; information, assistance, and counseling about Medicare and other supplemental insurance choices; assistance to access free or discounted prescription drugs; respite and other supportive assistance to family caregivers; and expansion and development of more home and community services and housing options. Services are targeted to people with the greatest social and economic needs.

### **Alternative Care Grants**

Grants pay for at-home care and community-based services for adults 65 and over who are assessed as needing nursing facility care, and have income and assets inadequate to fund nursing facility care for more than 180 days.

# CHILD CARE ASSISTANCE PROGRAM (CCAP) POLICY CHANGES

### Child Care Absent Day Policy

Exempts teen parents in specific supportive teen parent programs from being penalized when number of absent days exceeds 25 days per child, or 10 consecutive days, in a fiscal year. Allows for more flexibility for families who have a justified sick day.

# Parent Co-payments

- Reduces the highest amount a parent might pay in CCAP co-payments from 18% of a family's gross income to 14% of a family's gross income.
- Reduces the co-pay for families between 75 and 100% of the FPG from \$10 per month to \$5 per month.
- Establishes a new fee schedule for families on the BSF, MFIP and TY child care assistance programs.

# OTHER CHILD CARE POLICY CHANGES

# **School Readiness Service Agreements**

Allows the Commissioner to pay higher rates to approved child care providers who enter into school readiness service agreements (SRSA) and perform services that support school readiness for children and economic stability for parents. Providers are eligible for an SRSA if they provide full-time, full-year child care services, at least 25% of the children enrolled with the provider are subsidized through CCAP, and at least one of those children is expected to enter Kindergarten within 30 months. Providers who enter into an SRSA must comply with assessment and reporting requirements.

# **One-Time Visit with Unlicensed Providers Report**

Requires the Departments of Human Services and Health to create a plan to have one face-to-face interaction with unlicensed child care providers who receive CCAP funds. The visit could include provision of safety resources or early childhood development information. Requires a report due in January 2008.

### **Family Child Care License Fees**

• Caps the amount that counties can charge annually for family child care licenses at \$50.

# **At-Home Infant Care Program**

Dedicated funding for At-Home Infant Care, a program that offered certain lower-income parents of infants a choice between returning to work and receiving a child-care subsidy or staying home and receiving a monthly stipend, was eliminated.

# **HEALTH CARE PROGRAMS POLICY CHANGES**

### **Medical Assistance (MA)**

Medical Assistance (MA), Minnesota's Medicaid program, is a program jointly funded from the state and federal governments to pay for health care services provided to low-income individuals and families who meet specified eligibility criteria, and income and asset limits.

### **Covered Services**

- Provides coverage for coordination and patient education services provided by a licensed community health worker under the supervision of a medical assistance enrolled physician, registered nurse, or advanced practice registered nurse.
- Provides coverage for sign-language interpreter services during the course of direct health care service to enrolled recipients who have hearing loss.

### Prohibits MA coverage of:

Newborn circumcision, unless the procedure is medically necessary.

# Co-Payments

- Eliminates all co-payments except for non-emergency trips to a hospital-based emergency room and prescription drugs effective January 1, 2009.
- Reduces the monthly maximum co-payment for prescription drugs from \$12 to \$7 effective January 1, 2009.

### **General Assistance Medical Care (GAMC)**

GAMC is a state funded program that pays for certain health care services for low-income Minnesota residents who meet specified eligibility requirements and income and asset limits and are not eligible for other health care programs.

# Co-Payments

- Eliminates all co-payments except for non-emergency trips to a hospital-based emergency room and prescription drugs effective January 1, 2009.
- Reduces the monthly maximum co-payment for prescription drugs from \$12 to \$7 effective January 1, 2009
- Providers may not deny services to patients unable to pay co-payments.

# **Covered Services**

- Provides coverage for coordination and patient education services provided by a licensed community health worker under the supervision of a medical assistance enrolled physician, registered nurse, or advanced practice registered nurse.
- Provides coverage for sign-language interpreter services during the course of direct health care service to enrolled recipients who have hearing loss.
- Limits drug coverage to prescription drugs included in Medical Assistance coverage.

# **HEALTH CARE PROGRAMS POLICY CHANGES - CONTINUED**

### **MinnesotaCare**

MinnesotaCare is a state funded program that provides subsidized health care coverage to low- and moderate-income families and individuals who meet specified eligibility requirements, income and asset limits, and do not have access to affordable health insurance. Enrollees pay a premium based on income.

### **Eligibility Changes**

 Individual adults must have income below 200% of the federal poverty guidelines to remain eligible beginning January 1, 2008. Beginning July 1, 2009 individuals must have income below 215% of the federal poverty guideline to remain eligible.

# Co-Payments

- Eliminates \$6 co-payments for non-emergency visits to a hospital-based emergency room for pregnant women and children under age 21.
- Excludes mental health services from list of non-preventative visits to health-care providers requiring a \$3 co-payment.

# **Premium Changes**

MinnesotaCare enrollees with income above 100% of the FPG will have premiums reduced by 0.5 to 1% instead of the scheduled increase of approximately 8%.

### **Outreach Grants**

MinnesotaCare outreach grants address the importance of maintaining insurance coverage and on how to obtain coverage through the MinnesotaCare program in areas of the state with high uninsured populations. The Department of Human Services Commissioner must ensure that materials are available in relevant languages other than English.

### Limited Benefit Set for Single Adults and Households without Children

This benefit set is expanded, and all adults without children will receive the same set of benefits effective January 1, 2008.

# OTHER HEALTH CARE COVERAGE POLICY CHANGES

### Health Programs for Children (Medical Assistance and MinnesotaCare)

Extends coverage for children under Medical Assistance for two months after they have been deemed ineligible due to excess income. The child is then deemed automatically eligible for MinnesotaCare until renewal. Children's eligibility for MinnesotaCare is to be reassessed every 12 months.

Requires the Commissioner to develop a shortened health program application for children that does not exceed four pages in length and is easy to understand. The Commissioner of Human Services must also provide resources to assist in choosing managed care organizations through which children can receive health program services.

These provisions are effective October 1, 2008, pending federal approval.

# **Family Planning Services**

Raises reimbursement rates for family planning services provided by community clinics by 25%. This rate increase goes into effect July 1, 2007.

# LONG-TERM AND CONTINUING CARE POLICY CHANGES

### **Nursing Facility Rate Increases**

Increases nursing facility operating payment rates by 1.87% for the rate year beginning October 1, 2007. Specifies 75% of the rate increase in 2007 be used to increase wages, benefits, and pay associated with all employees, except management fees, the administrator, and central office staff.

A rebasing period will begin in the rate year beginning October 1, 2008 and continue through the rate year beginning 2014. This rebasing process is intended to shrink the disparity in funding to rural and metro-area nursing homes.

# **Home-Care and Supportive Housing for Seniors Report**

Requires the Commissioner of Human Services to study how the State of Minnesota can best assist those aged 65 and older choose long-term care alternatives that meet their needs and preferences and allow them to remain self-sufficient for as long as possible. A preliminary report is to be submitted to the legislative human services policy and finance committees by February 15, 2008, and a final report is due December 15, 2008.

# MINNESOTA FAMILY INVESTMENT PROGRAM (MFIP) POLICY CHANGES

Note: The following policy changes have various effective dates and related funding changes. Please see the Health and Human Services Omnibus bill and fiscal tracking sheets for further information.

# Treatment of Supplemental Security Income (SSI) Income

Eliminates the \$125 reduction of the cash portion of the MFIP grant for a household that includes one or more SSI recipients who reside in an MFIP household.

### Family Stabilization Services

Establishes Family Stabilization Services to help MFIP participants who are at risk of long-term welfare dependency or family instability due to physical disability, mental disability, age, or providing care for a disabled household member to reach the greatest possible degree of self-sufficiency.

### **Asset Limits**

Increases the asset limit for licensed vehicles owned by MFIP participants to \$15,000 loan value for families that own one vehicle and \$7,500 for additional vehicles. This change goes into effect January, 2008.

### Work Participation Bonus

Provides a Work Participation Bonus of \$75 per month for up to 24 consecutive months for MFIP participants who are losing the cash portion of MFIP benefits because of increased earnings and who meet certain work requirements. Months in which a participant receives the work participation bonus do not count toward the 60-month time limit for receipt of MFIP. This change goes into effect February, 2009.

### **Educational Employment Plans**

Changes requirements so that MFIP participants pursing education are not required to work in unsubsidized employment as a condition of educational employment plan approval.

### FOOD SUPPORT POLICY CHANGES

# **Eligibility Changes**

Requires the development of a simplified food support application, and changes reporting requirements to no more than every six months.

# **Canceled Benefits**

Repeals the requirement that food support benefits not access within 90 days of issuance be cancelled.

# **HEALTH POLICY CHANGES**

### **Human Papilloma Virus Vaccine Study**

Requires the Commissioner to reconvene a study of the human papilloma virus vaccine. The study shall include (1) the risks and benefits of the vaccine; (2) the availability and effectiveness of the vaccine; (3) the extent to which health insurance providers cover the cost of the vaccine; and (4) ways to cover the cost of the vaccine for those without health care coverage. The Commissioner shall submit a report to the legislature by February 1, 2008 along with recommendations as to whether the vaccinations should be mandatory statewide.

### Services to Sexual Assault Victims in Hospital Emergency Rooms

Chapter 42, S.F.1266

Requires hospital emergency rooms to provide emergency contraception, prophylactic antibiotics, and information to sexual assault victims.

### **Family Planning Clinics**

Chapter 139, H.F. 298

Permits family planning clinics in Minnesota to enter into cooperative purchasing agreements with governmental units to obtain pharmaceuticals and other supplies. The law also allows registered nurses to dispense oral contraceptives to women ages 12 and older. This law goes into effect August 1, 2007.

# **Post-Secondary Child Care Grant Program**

Helps low-income students with young children pay for child care while the student attends classes. Grant awards are based on family income and size and are made available to students who: have children 12 years and under (14 years and under if the child has a disability); do not receive assistance under the Minnesota Family Investment Program(MFIP); and need child care assistance in order to attend an eligible Minnesota post-secondary school.

 Increases the maximum child care grant by \$300 to \$2,600 per child, per academic year for a full-time student.

# HIGHER EDUCATION POLICY CHANGES

### **State Grant Calculations**

Increases the tuition and fee maximums and living and miscellaneous expense allowances used to calculate state higher education grant awards. Also reduces the assigned family responsibility factor by 4%.

# **Financial Management Information**

Each MnSCU institution is required to provide all students with personal financial management information. The University of Minnesota is requested to do the same.

# **Civil Legal Services**

Provides civil legal services for more than 20,000 vulnerable Minnesotans whose incomes are below the federal poverty guidelines to (1) protect the safety of children and help families break the cycle of abuse; (2) assist in securing child support and federal aid for low income families; (3) assist farm families to remain on their homesteads; (4) help prevent homelessness; (5) repair substandard housing; and (6) assist adults to move from welfare to work by overcoming legal obstacles.

• Specifies \$877,000 of the funding each year is to be used to improve the access of low-income clients to legal representation in family law matters.

# **PUBLIC SAFETY POLICY CHANGES**

# **Peace Officer Training Standards**

The Peace Officer Standards and Training Board shall revise and update preservice courses and develop in-service training courses related to no contact orders in domestic violence cases and domestic violence dynamics. The training must include a component to instruct peace officers on doing risk assessments of the escalating factors of lethality in domestic violence cases, instruction in the laws relating to no contact orders, and address how to best coordinate law enforcement resources relating to no contact orders.

### **Right of Domestic Abuse Victims to Terminate Lease**

A tenant to a residential lease who is a victim of domestic abuse and fears imminent domestic abuse against themselves or their minor children may terminate the written lease agreement without penalty. The tenant must provide advance written notice to the landlord accompanied by an order for protection or no contact order. The tenant is then responsible for the rent payment for the full month in which the tenancy terminates and an additional amount equal to one month's rent. The landlord may not disclose information by a tenant documenting domestic abuse.

# Qualified domestic violence-related offenses

Expands the definition of definition of "qualified domestic violence-related offense" to include an attempt to violate any of the crimes listed. Also adds first and second-degree murder to the list of qualified domestic violence-related offenses (which allows enhanced penalties to apply when a person commits more than one qualified domestic violence-related offense within a certain time frame).
